You may have seen that the Supreme Court of Western Australia handed down its decision in the long running dispute between Perth Airport and Qantas earlier today. Our media release is attached for your information.

The case reinforces the need for airports reform and a regime that allows for the timely, effective and efficient resolution of disputes.
