The Australian Competition and Consumer Commission is currently in the process of publishing the 2020-21 Airport Monitoring Report. One of the changes that we are making to this year's report is that we will publish a supplementary database alongside our report. This database will include data on financial and car parking topics that were covered in previous reports. In addition, the ACCC is proposing to publish data on the number of passengers that depart from and arrive at each terminal for each of the monitored

airports. This is in response to recommendation 9.4 of the recent Productivity Commission review into the economic regulation of airports.

We would like to seek your input on whether publishing the information on the number of passengers that depart from and arrive at each terminal for each of the monitored airports would damage your competitive position. If so, please specify which particular terminals you are concerned about and provide reasons.

We would appreciate your response by COB **Friday 1 June**.
