Have just confirmed you are correct. The excise rate which will apply following the end of the temporary reduction is 46.0 cents per litre. This amount includes the indexation which was applied on 1 August.

In regards to the end date of the temporary cut in fuel excise, it is legislated to end at 11.59pm on 28 September 2022. Which means the full excise rate will apply from 29 September 2022. We have adjusted the draft letter we discussed earlier to refer to 29 September.
