

Collective bargaining class exemption notice form

1. Who is in the collective bargaining group?

Describe or list the current members of the group and those who may join the group in the future.

If you have a small group that will not change, you can list the names of all members.

If you expect to add new members over time, you should provide a **general description of the members of the group.** For example: A group of dairy farmers in the Manning Valley area in New South Wales.

Motor vehicle dealers who are authorised resellers of Isuzu Truck motor vehicles pursuant to a franchise agreement with Isuzu Australia Limited ABN 97 006 962 572 and, who are members of the Motor Traders Association of Australia from time to time or members of the Australian Automotive Dealer Association from time to time (the "Group").

2. Who does the group propose to collectively bargain with?

If you intend to negotiate with just one particular target business, or a small number of known target businesses, you can list the names of each target business.

If you do not yet know all the businesses or organisations you will bargain with (e.g. your group will run a tender) or you expect to add new target businesses over time, you should provide a **general description of the type of target businesses the group intends to collectively bargain with**. For example: *Dairy processing companies*.

3. What does the group propose to collectively bargain about?

Describe the goods or services that the group proposes to bargain about with the target businesses. For example: Supply of raw milk.

The acquisition of motor vehicles, spare parts and accessories ("Target Products"), the acquisition of rights to sell Isuzu Truck vehicles and associated rights ("Franchise Rights") and the acquisition of training, services and various provisions ("Supplies");

Without limitation, the Group proposes that bargaining with Isuzu may include bargaining in relation to:

- availability and features of Target Products;
- the terms of supply and prices charged to dealers by Isuzu for Supplies;
- the prices charged by Isuzu for Target Products;
- discounts in respect of Target Products;
- holdbacks and rebates Isuzu pays to dealers;
- sales and other targets that are linked in any way to incentives, discounts, rebates and holdbacks;
- the prices paid by Isuzu to dealers for warranty work and related terms;
- the terms of any agreement setting out the terms under which Isuzu grants Franchise Rights to each member of the Group ("Franchise Agreements");

4. Contact details

This can be any member of the group or a nominated representative who is able to provide the ACCC with further information about the group if required.
