I lived at [REDACTED] just down the road. After Cyclone Ului in 2011? Strata insurance increased from \$35,000 I think to \$118,000. The body corporate did a lot of work and got it down to around \$80,000 still more than double.

I am fearful about what will happen here after Cyclone Debbie. Our levies are very high and will probably have to be even higher if the insurance increases which is highly likely.

The government should have a government insurance company as I have been they once did.
