- 4. Transition to 2nd-day Delivery Model: In numerous regions, Australia Post has already shifted to a 2nd-day delivery model. It is essential to inquire why, in the wake of such a transition, consumers are now threatened with further financial hardships. The current demand for traditional letter services has waned considerably, rendering such price hikes not only unjust but also unwarranted.
- 5. Safeguarding Consumers from Financial Consequences: It is the unassailable duty of Australia Post to shield Australian consumers from the financial repercussions of their management decisions or their artful accounting practices. If they want to grow their package business - they should gouge their package senders, not the guaranteed customers. It's criminal that the major threat to my business is the Postal Service. I sell lots of subscriptions, assuming a smaller increase. A 26% rise for a 2 year subscription that I sold just last month takes all of the profit out of it. The nett result to my business is the equivalent of losing half of an employee - and all of my meagre profit for the year. I'll end up employing 0.5 fewer staff and those funds will now be transferred to Australia Post. And this is where they'll spend it "Australia Post's eight senior executives collected \$4.45 million in bonuses last financial year, or about \$556,579 each. This increase will severely impact millions of Australians—small business owners, online retailers, and consumers, particularly consumers living in remote areas, elderly consumers, consumers with disabilities, as online buying is a necessity. 6. According to an Australia Post survey, in 2022, the eCommerce and online shopping industry grew at 23.4%. How is it then, that Australia Post is continually raising prices, by excessive amounts, for all their products? And how is it that they can constantly point to letter delivery losses as the reason for the increases when the parcel and large letters deliveries have substantially increased? The delivery of magazines runs on a specific Print Post service, comprising a mailing cost and an interstate linehaul cost - pricing is proposed to increase by up to 26.4% and 11.2% respectively. Facing a cost of living crisis, magazines are approaching luxury status and we are not in a position to increase our prices to consumers by the same percentages. We face relentless increases, no improvement in service levels, and a likely drop in delivery days from 5 to 3 weekdays in the near future.
		At the same time AP have recently stepped away from an 8yr arrangement to sell subscription across 126 magazines on behalf of 70 Australian publishers on their website. The activity yielding \$400K in sales revenue and close to \$200K in downstream mailing revenues, citing the activity as not being core to their business. They continue to sell air fryers on the site!
		Print publishing would be a major contributor to AP revenues. As an industry we are already under significant cost pressure across freight and materials and the ongoing increases to get our product to market is crippling. With their significant influence and bargaining power it is disappointing that there have been no specific initiatives to balance their need to increase costs by supporting publishers around packaging or delivery processes.

The proposed price hike risks hastening its demise and depriving future generations of this culturally significant practice.

Philately: Stamp collecting has been a widely loved pasttime since 1840. The proposed rate hike poses a significant threat to this historical and educational hobby.

Public Services

Equity of Access: Postal services must remain accessible and affordable to all Australians, irrespective of socioeconomic status or geographical location. The proposed rate increase contradicts this essential public service mandate.

Government Involvement

Role of the Minister for Communications: The Minister has the prerogative to disapprove the proposal within 30 days, and I urge the Minister to consider not just the economic but also the sociocultural impacts of the price increase.

Review into the Modernisation of Postal Services: The proposal brings up questions about whether the modernisation of postal services is indeed beneficial for all Australians, which should be evaluated carefully.

Transparency and Stakeholder Feedback ACCC's Preliminary View: I urge the ACCC to consider these broader implications when forming its preliminary view. This isn't merely a matter of cost recovery but has more expansive implications for the Australian public.

While Australia Post's operational costs are an important factor, they should not be addressed at the expense of sociocultural heritage, public service commitments, and the wider Australian community. I strongly recommend reconsidering the proposed price increase in light of these concerns.

Thank you for considering my views during this consultation process. I look forward to hearing about the ACCC's preliminary findings and hope that they will reflect the diverse needs and interests of the Australian community.

However, there is still a huge demand for their highly curated, informative and entertaining content, particularly to the over 50's demographic.) Print Postage cost inflation historically has sat at around 3-5% p.a. These modest annual increases, while still imposing an addition cost strain on these small businesses, are manageable. Increases in the magnitude of 15-18%, annually, will put many of these businesses out of business, thus reducing the demand for the print post product, reducing the revenue to Aust Post. Australia Post is also non-consistent in their use of measurement units for the calculation of postage cost, potentially confusing some customers. For example, Australia Post's envelopes and packaging correctly use the SI units of 'millimeters' in describing sizes on their packing products. Whereas, in Australia Post's on-line 'Postage Calculator' the units required for input are 'centimeters', which is an inconsistent and confusing use of measurements. It is noted that 'centimeters' are not the preferred SI unit for length adopted by the Australian Government. As a representative of a business	Oppose the proposed stamp price increase	I oppose the stamp increase for a number of reasons, which are outlined in detail in my full submission. In summary: 1) I submit that it is likely that there a discrepancies in financial reporting between the letter and parcel divisions, which are used as an attempt to justify the price increase - namely, that the letter division incurs costs against revenue (or lack thereof) from the parcel division. This view has been backed up by former CEO Christine Holgate, so they are not without merit. 2) I submit that a price increase for equivalent service of 214% in ten years, at a time when inflation in the same time frame is 26% total, is excessive. 3) I submit that price increases are excessive, and that Australia Post's data in their submission that they use to attempt to justify the price increases in one case uses a carefully selected timeframe and in another case compares Australian postage rates to international postage rates, but uses current prices for comparison to try to make their point-whereas using the proposed price figures provides a totally different picture. 4) I submit that Australia Post seeking to use international comparisons to justify postage rate increases again fails to show the whole picture, when other countries have increased stamp prices (most by less than Australia Post is proposing), but have either decreased parcel prices or offered low value parcel options, where Australia Post has simply increased everything, creating an unnecessary burden on business. 5) I submit that the major burden on the profitability of Australia Post is not due to their prices being too low, but due to the operation of international agreements under the Universal Postal Union. I suspect that this includes the reporting of delivery of small parcels (under 2kgs) coming into Australia Fost is not due to their prices for postage stamps together with recent significant increases in parcel rates, Australia Post is expecting Australiaa. And that through the current proposed increase in prices for postage stamps

		overseas. 8) I submit that there is significant forgery and counterfeiting operations in the market for postage stamps, and that Australia Post has been negligent in their duty to both themselves and to Australian consumers in undertaking efforts to remove fraudulent stamps from the market. I submit that this affects their profitability. I know it is widespread but I am obviously not empowered or resourced to investigate this, so it is unknown if this is a small or a large factor in their current profitability issues. But until this is investigated, it cannot be reasonably known, and any price increases should be put on hold until such time as this issue is at least addressed. 9) I submit that as Australia's National Postal Carrier, the mission of Australia Post should include ensuring that their prices are reasonable so as to not place unnecessary burdens on Australian Businesses the reduce their competitiveness with overseas competitors within the Australian market. And I submit that the pricing policies of Australia Post in general continue to make it very difficult for Australian businesses to compete in our own country against products coming in small packets from China. 10) I urge the ACCC and government to force Australia Post to address the issues raised above before they are allowed to increase stamp prices.

Oppose the proposed stamp price increase

I have multiple reasons for opposing the BPR increase, which are as follows:

- 1) I believe that Australia Post is first and foremost a public service that should be accessible and equitable for all Australians. I do not believe that a price increase of 25% to ordinary letters is consistent with such a value.
- 2) The increase to the BPR will likely diminish my personal social connectivity, as I conduct a substantial proportion of my communications with friends and family via Australia Post. Given I am homebound and unemployed with a disability and cannot access concession stamp prices (see below) I will have to pay an extra cost to stay connected to friends and family in the manner that I prefer, or communicate less frequently. Either outcome will have a negative impact on my quality of life.
- 3) I note that the price of concession stamps will remain the same, with the purpose of reducing the financial burden on disadvantaged people. However, the mechanism to apply for such a concession is, I believe, discriminatory. In order to receive a concession rate, a person must attend an Australia Post outlet in person. This excludes people with a range of conditions and disabilities (e.g. some mobility difficulties and some mental illnesses). These are people who are already likely to be suffering financial stress. This policy means that people such as myself will still have to pay the increased price of stamps, or not send letters. In regard to my own situation, I am unable to go to a Post Office to receive the concession for which I am eligible. I would be more likely to support increases to the BPR if the concession price was more widely accessible.
- 4) The "Draft Notification" fails to discuss the impact to consumers of an increase in the price of large letters. A 25% increase makes the largest letters (to 500g) \$1.50 more expensive. Larger letters may include items that cannot be replaced with digital communication e.g. certain types of small gifts (appropriate to posting guidelines) that enhance friendship, belonging and wellbeing. In regard to my personal use of Australia Post, a number of the letters that I send and receive are larger ones. However, as already mentioned above, I will have to reconsider this due to the increased expense.
- 5) I also note that the price of posting seasonal greeting cards will remain the same. Yet, such a card is not equivalent to an ordinary letter, due to the strict weight requirements and limited time of year in which it can be sent. However, if reduced "card only" prices were available all year (and expanded to include postcards), I would be more likely to support a rise in the BPR, as it would allow for some form of postal communication at a more accessible price.
- 6) Australia Post already raises the BPR by almost 10% every year, at least in recent years.
- 7) Australia Post proposes a new "long-term pricing path"

		("Draft Notification", p.5), but fails to define what this means. I cannot support a proposal that lacks detail. What is the time frame under consideration? Does it mean that the BPR will remain stable in the near future, or can further, regular increases be expected?
		8) I am concerned that if 25% becomes normalised as the new standard for annual BPR increases, then in 5 years time (January 2029), the cost of sending a small letter within Australia would be approximately \$4.50. Under this regime, sending letters would likely become a luxury that only the financially privileged can afford, undermining the principle of Australia Post being an "equitable" service ("Draft Notification", p.8).
		9) Regular price increases will likely ensure that fewer and fewer people will come to use the letter service. Each decrease in service usage will then inevitably be used to justify further BPR increases in what appears to be a self-fulfilling process.
		10) I have strong reservations about Australia Post using private contractors who have vested economic and/or political interests to conduct research on matters relating to the public good. Any proposals based on such research cannot necessarily be trusted to be within the public's interests. An organisation that is as nationally important as Australia Post should not readily make changes based upon the advice of companies whose primary purpose is making profit, rather upholding a universal and equitable service.
