The new call for EOIs follows the introduction earlier this month of a temporary revised shipping allocation system to relieve the congestion this year at WA grain ports. Allocations under the first round of EOIs – for the period from April 20 to May 31 – have now been finalised with a total of 1.3 million tonnes scheduled to be shipped over the six-week period.

The second round of shipping slots on offer is for 1 June to 31 August. Marketers wishing to book slots in this time will need to submit their EOIs by 5pm Western Standard Time Friday 27 March 2009.

### **Access to Co-operative Bulk Handling Limited Port Facilities and Services**

Co-operative Bulk Handling Limited ("CBH") is willing to provide access to port terminal services to accredited wheat exporters for the export of wheat:

- on terms and conditions set out in any relevant Grain Services Agreement that CBH has with the

relevant accredited wheat exporter, provided the relevant accredited wheat exporter is not in breach of those terms; or

- if no agreement has been entered (either expressly or as a result of acceptance by conduct), on the terms and conditions and upon payment of the prescribed charges set out in the standard Grain Services Agreement until 30 September 2009, provided the accredited wheat exporter is not in breach of those terms.

The procedure for obtaining access to CBH's Port Facilities and CBH's management of the shipping stem is governed by the Grain Services Agreement and CBH's Export Accumulation Guidelines and Port Queue Policy. CBH allocates positions on the shipping stem in accordance with the Export Accumulation Guidelines and the Port Queue Policy with a view to managing each Facility to balance the competing priorities of efficient grain transportation, efficient terminal operation, effective fumigation practices and good service to all shipping customers including accredited wheat exporters.
