## Application to Vary 2011 Undertaking – seeking comment

Viterra Operations Ltd has made an application under section 44ZZA(7) of the *Competition and Consumer Act 2010* to vary its 2011 Undertaking.

The proposed variation extends the timeframe by which Viterra must introduce an auction system, provides the ACCC with greater flexibility in its ability to withdraw an Auction Variation Notice, and includes arrangements for reopening the shipping stem for the 2012-2013 export season if an auction system has not yet been introduced.

The ACCC invites industry and interested stakeholders to make submissions by 7 May 2012.
