- 1. Insurance is a statutory requirement for strata companies in WA (our state for business registration)
- 2. Our strata management staff does not have insurance industry experience or knowledge of insurance products
- 3. Our office does not have staff available to become providers of strata insurance products
- Insurance brokers provide open market competitive quotes from a number of insurers to our clients
- 5. The decision to accept an insurance quote is made by owners with insurance cover an obligation of current legislation
- 6. The obligation to disclose commissions reflects a conflict of interest. We reject all perceived or real conflicts of interest.
- 7. Our business is strata management and derives income in this capacity; not as insurance specialists (or representatives)
- 8. Our fees are competitive without receipt of commissions and our service to clients (strata companies) is not diminished
- Our belief is that insurance commissions are not earned as claims by our clients (strata companies) are minimal and managed by insurance brokers in a prompt, courteous and professional manner
- 10. Insurance brokers are part of a highly regulated industry therefore we believe commission income should remain in a regulated environment
