### Why regulate?

- Cost of regulation and regulatory errors
- Competing pipelines
- Greenfields gas projects
- Non-integrated/ring fenced
  networks









## **Defining incentive regulation**

- Working definition:
  - revenue/price control, not profit control
  - regulatory review periods
  - incentives to improve efficiency
- Different perspectives









## **Comparing theory and practice**

- Short-term focus on identifying perceived monopoly rents
- Review periods short in 'asset life' terms
- Lack of strong or equitable incentives for efficiency

\* First year efficiency gains only

- Scope of assessment relatively narrow
- Alternative approaches:
  - price monitoring
  - price-service offerings
  - cost-based 'glidepath'
- Criteria for assessment
