Rural Doctors Association of Australia Limited application for revocation of authorisation A91376 and substitution of new authorisation A1000427—interested party consultation

The Australian Competition and Consumer Commission (the ACCC) has received an application for re-authorisation from the Rural Doctors Association of Australia Limited (RDAA), (revocation and substitution). The ACCC invites you to comment on the application. Please see pages 20-28 the ACCC's publication <u>Guidelines for authorisation of conduct (non-merger)</u> for a summary of the authorisation process and how to make a submission to the ACCC.

The RDAA and its state associations have sought re-authorisation to continue to collectively negotiate with state and territory health departments, Country Health South Australia and Western Australia Country Health Service, on behalf of rural doctors. The negotiations relate to the terms and conditions under which rural doctors, including GPs and locums, provide services in public hospitals and health facilities as Visiting Medical Officers and provide afterhours services. The RDAA also seeks to extend authorisation to collectively negotiate with Victorian Local Hospital Networks, certain specified Primary Health Networks and Queensland Hospital and Health Service (HHS) areas.

The ACCC notes that the proposed collective negotiating arrangements are voluntary for all relevant parties and that authorisation of collective boycotts *has not* been requested.

Request for submissions

The ACCC invites you to make a submission on the likely public benefits and effect on competition, or any other public detriment, from the proposed arrangements.

If you intend to provide a submission in relation to the RDAA's application for reauthorisation, please do so by **31 August 2018**. Submissions should be emailed to adjudication@accc.gov.au with the subject AA1000427 – RDAA – submission'.

Submissions, will be placed on the ACCC's public register subject to any request for exclusion. For further information see the ACCC's publication <u>Guidelines for excluding</u> information from public register.

December 2018	Final determination.
