Health Partners Limited – Application for authorisation AA1000636 – Supplementary information provided by the Applicant

As noted in our earlier correspondence dated 1 March 2023, the Australian Competition and Consumer Commission (**ACCC**) received an application for authorisation from Health Partners Limited (**Health Partners**) on 16 February 2023.

On 27 April 2023 and 11 May 2023, Health Partners submitted further information to supplement its application, which is **attached** and available on the ACCC's [authorisations public register](#).

This letter is to invite you to comment on the further information the ACCC has received. You are welcome to pass this letter on to others who may wish to make submissions.

In particular, the ACCC is seeking responses to the following:

1. Will the likely public benefits and detriments of the proposed conduct vary depending on the number of agreements Health Partners enters into with South Australian dental practices and the location of those practices? If so, how?
2. Given the new information provided by Health Partners (including in relation to 'minimum standards'), do you have a view on the likely public benefits or detriments resulting from the proposed conduct?
3. Is there further information which may assist the ACCC in assessing the public benefits and detriments of the proposed conduct?

Making a submission

The ACCC invites you to make a submission on the above questions. In making your submission, please provide information, evidence and views about the likely public benefits, effects on competition and any other public detriment that you consider will result from the proposed conduct.

If you intend to provide a submission on the questions above, please do so by **23 May 2023**.


If you wish to request an extension, please contact us on the details below as early as possible. Submissions after the due date (or after any extension granted) may not be taken into account.
