Virgin Australia & Alliance Airlines application for authorisation AA1000615 – extension of time for submissions and final decision

The purpose of this letter is to advise that the ACCC has updated the timeline to make a final determination on the application for authorisation AA1000615 lodged by Virgin Australia and Alliance Airlines, and extended the period to make a submission following the release of its draft determination on 21 October 2022.

The ACCC has determined, and the Applicants have agreed, to extend the period for the ACCC to make a final determination in this matter until 24 May 2023.

While the period has been so extended, the ACCC is progressing its assessment and aiming to make a final determination in this matter in **March 2023**.

This extension has also enabled the ACCC to allow until **25 November 2022** for interested parties to make submissions following the ACCC's draft determination.

Competition Exemptions

Attachment A

General:

Broadly, the ACCC is seeking submissions from interested parties on the following issues:

- The current state of competition in the supply of FIFO services nationally, including whether and the extent to which:
 - the Charter Alliance has promoted and is likely to promote competition by imposing an additional competitive constraint on Qantas by providing an integrated service offering, particularly on the East Coast and in Central Australia.
 - other FIFO operators such as Qantas and the smaller FIFO operators are able to impose an effective competitive constraint on the Charter Alliance for opportunities in Western Australia.
- The likelihood of any efficiencies or cost savings realised from the Proposed Conduct being passed through to acquirers of flight services.
- The likelihood of new entry or expansion of smaller FIFO operators on the scale necessary to compete with FIFO operators such as the Charter Alliance and Qantas.
- The extent to which the loss of competition between the Applicants is likely to materially enhance the ability and incentive of the Applicants to unilaterally raise prices or reduce services.
- Any other issues you consider relevant to the ACCC's assessment of this matter.

FIFO customers:

The ACCC is also seeking submissions from FIFO customers on the following issues:

- The main factors that customers consider when awarding a tender contract.
- The significance of each of the following public benefit claims made by the Applicants in deciding whether to award a contract for the provision of FIFO services:
 - the availability for an integrated offering of charter and/or RPT services with a single provider (or alliance)
 - improved connections between Terminal 1 and Terminal 2 at Perth Airport, reducing connection time for FIFO passengers
 - o access to a Frequent Flyer program and airport lounges
 - access to a complementary fleet of aircraft, with diverse seating capacity, and a national footprint.
