#### AusNet's actual or potential competitors - transmission

A number of other transmission network service providers may compete with AusNet for example in relation to contestable augmentations (see the companies listed in 1 to 4 below). APA, historically a gas transmission company, recently acquired Basslink and is a competitor.

In addition, grid-scale load or generators may construct their own connection assets (ie, Crowlands Windfarm) and, in some instances, shared network assets (ie, Alcoa Portland Smelter – which holds an exemption for its ownership, control and operation of the shared network facility at the Smelter) in Victoria.

Also, the processes that are being run for renewable energy zones in NSW are contestable and open to a wide range of participants. For example, no TNSPs were successful in the expression of interest phase for the Central West Orana Renewable Energy Zone in NSW. Consortia involving NSW electricity distributers, APA and various constructors, and financiers/sponsors progressed to the subsequent stages.
