Qantas Airways Limited & China Eastern (AA1000624-1) (Application): Response to ACCC Request for Information

Thank you for your email dated 11 August 2023.

The Applicants set out their response below, which replicates the ACCC's questions in the email for ease of reading. Capitalised terms in this submission have the same meaning as set out in the Application.

- 1. For each city pair route on which China Eastern has operated between Australia and China since January 2019, please provide the following monthly data:
 - a. Average load factor (January 2019 to latest available)
 - b. Total number of passengers flown (January 2019 to latest available).

2. In relation to Qantas' soon-to-recommence daily Sydney-Shanghai services, please provide information about current bookings and expected capacity utilisation from 29 October 2023 until 31 March 2024.

The ACCC notes recent news of China's reinstatement of Australia's approved destination status and Tourism Australia's recent \$125m investment in the promotion of Australia as a destination in China. What effect, if any, do the Applicants expect these developments will have on passenger demand for travel between Australia and China in the period from September 2023 to 31 March 2024.

The Applicants welcome the developments noted in Question 3. In the Applicants' view, both developments will encourage demand particularly in the seasonal holiday periods around 1 October 2023 (China National Day Holiday) and the Chinese New Year (10 February 2024), and help the market restore to pre-COVID levels sooner.

However, it is not expected that these developments will lead to any material change in forecast demand before March 2024.

- 4. How do the developments described in question 3 impact the capacity the Applicants plan to operate between now and 31 March 2024:
 - a. on the Sydney-Shanghai route?
