Request for submissions: Cleanaway's proposed acquisition of certain Suez post-collection waste assets in Sydney

The Australian Competition and Consumer Commission (ACCC) is seeking your views on the proposed acquisition of certain Suez Recycling & Recovery Pty Ltd (Suez) post-collection assets in Sydney by Cleanaway Waste Management Ltd (Cleanaway) (the proposed acquisition).

Cleanaway and Suez both supply waste processing and disposal services in Australia. Further details regarding the acquisition can be found at **Attachment A.**

The ACCC's investigation is focused on the impact on competition, particularly in Sydney. In particular, we are seeking your views on:

- how closely Cleanaway and Suez compete with each other in supplying various waste processing and disposal services
- whether the price of waste processing and disposal services would be likely to increase, or service levels decrease, as a result of the proposed acquisition, and
- whether Cleanaway and Suez's customers will have alternative suppliers (actual and/or potential) of waste processing and disposal services after the proposed acquisition.

Further issues you may wish to address are set out in **Attachment B**.

This matter is public and you can forward this letter to anybody who may be interested.

The legal test which the ACCC applies in considering the proposed acquisition is set out in section 50 of the *Competition and Consumer Act 2010*. Section 50 prohibits acquisitions that are likely to have the effect of substantially lessening competition in a market.

Attachment A

Cleanaway

Cleanaway (ASX: CWY) is a publicly listed company and is headquartered in Melbourne, Victoria. Cleanaway supplies recycling, waste management and industrial services.

Suez

In Australia, Suez operates a waste management business that supplies waste collection services and owns and operates transfer stations, landfills and alternative waste treatment (**AWT**) facilities.

Suez is a part of the SUEZ Group (S.A.S), a listed holding company headquartered in France with global operations.

The proposed acquisition

Cleanaway proposes to acquire multiple waste processing and disposal facilities in Sydney from Suez, including contracts and other assets related to the facilities.

Cleanaway and Suez both currently supply, or in the near future may supply, the following waste disposal services listed in the table below. Cleanaway seeks to acquire all of the Suez assets listed below.

Suez also owns transfer stations at Seven Hills, Wetherill Park and Spring Farm, organics processing facilities at Eastern Creek and Spring Farm, and a site at Chullora which is currently closed for redevelopment. These assets will not be acquired by Cleanaway.

- 8. Please identify and describe the location and types of waste processing and disposal services (for example putrescible or non-putrescible waste, landfill or transfer station) you supply in Sydney. Please identify any subcontracting arrangements with either of Cleanaway or Suez.
- 9. Please identify who you consider to be your competitors in each of those services/geographical areas.
- 10. Please explain whether you have any excess capacity to expand your operations or the ability to expand your capacity in response to increased demand in the Sydney region.
- 11. Please describe the cost, necessary assets and infrastructure, and any regulatory requirements such as licences and environmental approvals for each of the waste processing and disposal services you provide.
- 12. If you currently use any of Cleanaway or Suez's waste processing facilities and/or landfills, please describe any alternative facilities available to you.
- 13. Please describe any impact the proposed acquisition will have on the development of EfW facilities and competition to acquire putrescible waste.
