Please find below our replies to the additional queries listed in your email Monday, 21 September 2020.

1. Please estimate how many pharmacies nationally compete to supply prescription medications to consumers.

There are approximately 5,700 community pharmacies in Australia (Pharmacy Guild of Australia https://www.guild.org.au/ data/assets/pdf file/0020/12908/Vital-facts-on-community-pharmacy.pdf)

2. Please describe API's ownership structure. Are any individual pharmacies franchises, or are pharmacies ultimately API owned?

API is an ASX listed public company that operates a franchise retail model. Pharmacies are owned by pharmacists, either as individual franchise owner operators, or owned in partnerships with other pharmacists.

Pharmacies are not owned by API. Pharmacy ownership is regulated by the States and Territories and strictly limits pharmacy ownership to registered pharmacists. These state-based regulations also determine the number of pharmacies an individual pharmacist may own in each state or territory.

3. While we understand that SiSU may not have specific contact information for competitors, please provide contact information for industry participants and regulatory authorities that SiSU has dealt with in relation to the proposed conduct. 4. At question 9 you refer to 'recent changes in prescription legislation'. Please identify this legislative change, and the regulator overseeing this change.

Legislative changes were made in late 2019 that acknowledged the use of electronic prescriptions as an alternative to a paper-based prescription. Amendments to the *National Health (Pharmaceutical Benefits) Regulations 2017*, were published on 30 October 2019 and meant that electronic prescriptions were to be recognised as valid prescriptions.

The regulator overseeing this change was the Australian Government – Department of Health.
