- Woolworths provided an update on the reprocessing capacity in Victoria, noting that one soft plastics processor is now operational and two other processors, are also progressing, with
- Woolworths provided an update on the stockpile in NSW, noting that Woolworths and Coles' focus was ensuring there was sufficient and sustainable soft plastics processing capacity in NSW in the first instance. Woolworths noted that is in the process of building their facility. Woolworths and Coles noted that they would look to provide an update as to the status in NSW at the next Taskforce meeting.
- Woolworths noted that Government support to stimulate offtake markets for recycled materials would be appreciated to ensure a sustainable soft plastics recycling industry.

- ALDI confirmed that the trial was running smoothly in ALDI stores from an operational perspective and customer feedback to date had been positive.
- Coles also confirmed that it had received positive customer feedback to the pilot. Coles
 noted that it has responsibility under the trial for auditing the collected material and
 intended to undertake the first round of sortation and testing in the coming week. This
