UNDERTAKING GIVEN TO THE AUSTRALIAN COMPETITION AND CONSUMER COMMISSION UNDER SECTION 44ZZA OF THE TRADE PRACTICES ACT 1974

This undertaking is given by Victorian Power Exchange Pty Ltd (ACN 080 200 371)

1. Effective date

This undertaking has effect from the date on which it is accepted by the Australian Competition and Consumer Commission (the ACCC).

2. Expiry date

This undertaking expires on 31 December 2010.

3. Interpretation

Words appearing in italics in this undertaking have the meaning given to them by Chapter 10 of the *National Electricity Code*.

4. Undertaking

On registration by *NEMMCO* as a *Network Service Provider*, Victorian Power Exchange Pty Ltd undertakes to provide access to the *network services* of its *transmission networks* on the terms and conditions set out below.

5. Terms and conditions of connection and access

 - (ii) good electricity industry practice and applicable Australian Standards.

Our understanding is that copies of those instruments applicable to particular distribution *Network Service Providers* will be provided by the relevant *Network Service Provider*.

6. Terms and conditions of connection and access
