Certification Trade Mark Application No. 2243358 lodged by Circular Energy Holdings Pty Ltd

The Australian Competition and Consumer Commission (**ACCC**) has received an application from Circular Energy Holdings Pty Ltd to register Certification Trade Mark No. 2243358 (**the CTM**). The current proposed Rules were provided on 29 March 2023, replacing the previous set of Rules received on 24 June 2022.

I am writing to you as a party who may be interested in commenting on the application.

The proposed rules provide that the CTM may be used by an organisation that acceptably meets the requirements of the Sustainable Energy Commitment criteria. The criteria represent an organisational commitment to 9 ESG categories and 20 sub-categories of criteria and have been designed to support the planning, implementation and stewardship of the optimal path to 24/7 Sustainable Energy including verification of progress at any point of time.

We invite your views on any aspect of the application, including whether Circular Energy Holdings' Sustainable Energy Commitment CTM and its associated rules are likely to raise any competition concerns or may result in consumers being misled. In particular, the ACCC is interested in your views on whether the standards contained in the rules would ensure that an organisation has engaged in a "sustainable energy commitment" in a way that is consistent with what Australian competitors and consumers may reasonably expect.

Certification trade marks

A certification trade mark (**CTM**) is an image or series of words which identifies that a good or service is of a particular standard – for example, with regard to quality, origin, material or mode of manufacture. Each CTM has rules that govern the use of the CTM and include the requirements that goods or services must meet to in order to display the CTM and the processes the CTM owner will use to decide whether these requirements have been met.

Registering a CTM under the *Trade Marks Act 1995* (Cth) (**TMA**) gives its owner the exclusive right to use the CTM and to allow other people to use it according to the rules.

The ACCC has a role to assess CTMs particularly whether they raise consumer protection, competition or associated concerns. In addition, the ACCC will assess the requirements in the rules that goods or services must meet in order to have a CTM applied to them.

The CTM application

Circular Energy Holdings Pty Ltd has applied to register the Sustainable Energy Commitment CTM, illustrated below. The CTM intends to certify that an organisation has made a commitment to acceptably meet the Sustainable Energy Commitment Criteria as set out in the CTM Rules.

The ACCC invites you to comment on the applications before it issues an initial assessment. If you wish to comment please do so by **22 November 2023**.

Submissions will be placed on the ACCC's public CTM Register, subject to any request for exclusion. Please indicate clearly in your submission whether you are willing for the ACCC to make it publicly available by placing it on our CTM Register, or are requesting that part or all of it be excluded (with brief reasons for exclusion).
