## CONSENT TO WITHDRAWAL OF SECTION 87B UNDERTAKING

## **BACKGROUND**

- 1. On 17 December 2015, the Australian Competition and Consumer Commission (ACCC) accepted an undertaking (the undertaking) given by CC 1 (2011) Limited, Max-Inf (Ningbo) Baby Product Co. Limited and Britax Childcare Pty Ltd (together, the undertaking parties) pursuant to section 87B of the Competition and Consumer Act 2010 (the Act) in relation to the proposed acquisition by Nordic Capital Fund VII of a 60 per cent interest in Max-Inf Holdings Limited (the proposed acquisition).
- To address the ACCC's competition concerns, the undertaking required the undertaking parties to continue to supply Infa-Secure Pty Ltd (Infa-Secure) with child restraint systems pursuant to a transitional supply agreement, while Infa-Secure established alternative supply arrangements.
- 3. On 9 December 2018, the transitional supply agreement expired.
- 4. On 10 December 2018, the undertaking parties sought the ACCC's consent to the withdrawal of the undertaking pursuant to s 87B(2) of the Act.
- 5. The ACCC consulted with Infa-Secure in relation to the withdrawal request. Infa-Secure does not object to the withdrawal of the undertaking.

## WITHDRAWAL

6. In accordance with s 87B(2) of the Act, the undertaking is withdrawn in its entirety, with effect on and from the date on which the ACCC gives its consent to the withdrawal.
